Professor Theo Haupt

Professor Haupt has been involved in health and safety (H&S) practice and research for several years with a PhD from the United States focusing on alternative approaches to the management of H&S on construction sites. He has published extensively and delivered several papers on the subject in national and international journals and conferences. He regularly reviews papers on H&S

and construction industry development issues for a range of internationally acclaimed journals and serves on several editorial boards. Professor Haupt has co-authored chapters on H&S in a number of books. He is heavily involved in the International Council for Research and Innovation in Building and Construction (CIB) Work Commission W99 (Safety and Health in Construction). Given his interest in the "people" aspects of construction, his primary recent research interest includes many aspects of construction worker safety and health with particular emphasis on the performance approach to safety management, workers' compensation premium fraud, accident causation, safety and health interventions, impacts of diseases such as tuberculosis and HIV/AIDS on construction workers, and the plight of aging construction workers. His recent focus is on the cost implication of the present OH&S legislative and regulatory framework in South Africa. He has served on the Advisory Council for Occupational Health and Safety of the Minister of Labour.

Learning Methodology
